Sudden Oak Death Summit

Supervisor Murray advised that the sudden oak death summit sponsored by Marin County will be held tomorrow and will include several representatives from state and federal government.

Marin Economic Commission Award Luncheon [Supervisors, Board of] Supervisor Murray advised that the Marin Economic Commission award luncheon will be held on Thursday, at which time the Board of Supervisors' Business of the Year award will be presented.

San Rafael Rock Quarry

[Use Permits]

Supervisor Kress acknowledged the presence of several residents of neighborhoods in proximity to the San Rafael Rock Quarry and invited them to speak during open time.

Benefit Art Exhibition and Sale [Open Space District] Supervisor Rose advised that the benefit exhibition and sale of Marin County landscape paintings held at the Bay Model in Sausalito earned approximately \$48,000 in sales, with approximately \$15,000 to \$20,000 being donated to the Open Space District.

Supervisor Kinsey directed staff to research the possibility of adding, at some time in the future, a contract provision within the Super Williamson Act to require that when lands are being subdivided within the Williamson Act, the new parcel that is created would be required to return to the full term of the Williamson Act.

18. HEARING: ORDINANCE AUTHORIZING IMPLEMENTATION OF THE ORGANIC CERTIFICATION PROGRAM AND ORGANIC CERTIFICATION FEE SCHEDULE

[Agricultural Commissioner]

By letter dated October 31, 2000, Agricultural Commissioner/Director of Weights and Measures Stacy Carlsen submitted his report regarding the above-referenced item and recommended that, after conduct of a public hearing, the Board adopt the proposed ordinance authorizing implementation of the organic certification program and organic certification fee schedule.

The hearing was declared open to receive public comment. There being no comment, the hearing was closed.

M/s Murray-Kress, to adopt Ordinance No. 3317 setting fees for organic certification of producers of organic products.

19. HEARING: APPEAL ON PERSONNEL COMMISSION DECISION, SUSPENSION APPEAL #00-38, PURSUANT TO MARIN COUNTY MERIT SYSTEM, SECTION 2.56.090 [Human Resources]

By letter dated October 31, 2000, on behalf of the Departments of Human Resources and Public Works, Human Resources Director Laura Armor submitted her report regarding the above-referenced matter. Mr. Armor advised that George Petracopoulos was present with his attorney pursuant to his right under Marin County Code Section 2.56.090 to appeal the decision of the Personnel Commission, and recommended that the Board uphold the Personnel Commission's decision of July 12, 2000, regarding Suspension Appeal #00-38 and deny appeal. Ms. Armor advised that the entire evidence list was provided to the Board members, including tape recordings of the Personnel Commission's hearing.

County Counsel Patrick Faulkner advised that, under Marin County Code 2.56.090, this appeal is based solely upon the record that has been provided unless the Board makes an express finding to open it up to new evidence. Mr. Faulkner also advised that the standard of review for this appeal is de novo which means Board members can exercise their own independent judgement regarding the evidence which was provided at the Personnel Commission hearing.

(Supervisor Kinsey absent at 11:25 a.m.)

The appellant's Attorney, Jeffrey Daly, advised that the appellant is not questioning public policy setting up random drug testing, nor does he believe that this appeal sets a countywide precedent. Mr. Daly stated that it is the appellant's contention that there was an error made at some point during the collection, testing or reporting of Mr. Petracopoulos' urine sample. Mr. Daly presented arguments to support this conclusion and urged the Board to consider Mr. Petracopoulos' prior job performance and grant him the benefit of the doubt in this appeal.

Deputy County Counsel Mari-Ann Rivers, who presented the case for the County at the Personnel Commission hearing, briefly described the random drug testing procedure and challenged Mr. Daly's assertion that granting this appeal would not create a precedent. Ms. Rivers advised that all procedures were followed and the chain of custody of the urine sample was testified to before the Personnel Commission. Ms. Rivers stated that the abundance of evidence clearly shows that Mr. Petracopoulos' urine sample was adulterated.

In response to questions by Supervisor Kress regarding the workload of the Kentfield Laboratory and the number of County employees who are requested to go to the Lab and give a urine sample on any given day, Ms. Armor advised that the County selects between seven and eight employees to go for drug testing on any one day. Ms. Rivers stated that, prior to this incident, there had been no problems associated with the testing program. In response to questions by Supervisor Kress regarding clarification of drug testing procedures and the nitrate levels found in Mr. Petracopoulos' urine sample, Ms. Rivers stated that the testimony given before the Personnel Commission by Neil Fortner, Vice President and Chief Scientific Officer with PharmChem Laboratories, was that the nitrate count found in Mr. Petracopoulos' urine sample could not have occurred naturally.

(Supervisor Kinsey returned at 12:12 a.m.)

In response to a question by Supervisor Kress, the appellant's Counsel, Mr. Daly, stated that he concedes that the urine sample was adulterated but does not concede that the sample was Mr. Petracopoulos' sample or that the sample

could not have been adulterated by a cleaning substance or some other similar material used in Mr. Petracopoulos' job.

After discussion by Board members and staff and closing remarks by Mr. Daly, M/s Kress-Rose, to uphold the Personnel Commission's decision of July 12, 2000, and deny the appeal of the disciplinary action (two week suspension) of Traffic Safety Maintenance Worker George Petracopoulos.

Supervisor Kress noted that Board members should review this case as if they were a jury in court and ask themselves if the preponderance of evidence supports the Personnel Commissions' decision. Supervisor Kress stated that it seems clear that the urine sample was adulterated and the preponderance of evidence shows that all the procedures were conducted appropriately. Supervisor Kress added that this finding does not determine whether a controlled substance was used but simply that the drug sample was adulterated, which constitutes a refusal to test.

In response to a question from Supervisor Brown regarding the Board's ability to alter consequences, County Counsel Patrick Faulkner advised that Department of Transportation regulations define procedures and requirements in this case.

Agricultural Commissioner/Director of Weights and Measures Stacy Carlsen made introductory remarks regarding the information contained in his letter dated October 31, 2000, pertaining to the above-referenced item. Mr. Carlsen briefly summarized the background of the issue before the Board, commented on the County's past support for the ranching community and the Board's previous approvals of agreements with the United States Department of Agriculture ("USDA") Wildlife Services Agency for predator control, outreach and education. Mr. Carlsen also briefly commented on the impact of the voter-approved Proposition 4, commented on efforts of ranchers to implement non-lethal programs, summarized the County's actions during the past year to address predator control issues and briefly discussed the goals of the Five-Year Action and Strategic Plan for Wildlife Control. Mr. Carlsen noted that approval of the

Five-Year Action Plan would result in a program that moves the County away from funding a lethal predator program in eighteen months.

Mr. Carlsen also briefly responded to comments and concerns expressed by the Marin Coalition for California Wildlife as presented in their letter dated October 30, 2000, submitted to Board members, regarding the recommendations contained in Mr. Carlsen's staff report. Mr. Carlsen stated that the Coalition endorses the proposed Plan for wildlife control, and briefly commented on concerns expressed by the Coalition including accountability and administration of a proposal to fund the Northbay Woolgrowers Association to implement non-lethal predator control activities.

Mr. Carlsen then addressed the Board on the specific recommendations in his staff report, noting that he expects that no one will be 100 percent happy with the recommendations. Mr. Carlsen stated that his recommendations include a funding request in the amount of \$50,000, to help ranchers offset costs associated with non-lethal activities on the ranches. Mr. Carlsen emphasized the importance of sustainability of the livestock industry and requested that the Board support the Strategic Plan for Wildlife Control Techniques and approve the Five-Year Action Plan for Livestock/Wildlife Protection programs. Mr. Carlsen noted that the Five-Year Plan doesn't expire in five years, but rather, that the Plan provides a guide for predator control activities during the next five years.

Thereafter, Mr. Carlsen introduced Mary Paglieri, founder and Director of the Little Blue Society ("LBS"), and James Nee, LBS Senior Director, who briefly described three elements of the LBS' proposed plan to implement a non-lethal program including: building and fortifying fences, the Guardian Shepherd program, and community outreach. The representatives of the LBS also briefly described the goals of their plan and identified other localities where they have worked.

The hearing was declared open to receive public comment.

Representatives of In Defense of Animals, the Marin Coalition for California Wildlife, Animal Legal Defense Club, Wildcare, Marin Humane Society and three County residents addressed the Board and commented generally on concerns regarding wording in the proposed Strategic Plan related to funding the Northbay Woolgrowers Association, including ensuring sufficient oversight, accountability and administration of a proposed agreement with the Woolgrowers Association; the representativeness of the Northbay Woolgrowers Association of other agricultural producers; oversight by County staff and County staff time to be spent to monitor predator control issues, clarification of the term "sunseting" related to the USDA agreement with the County, time frame for phasing out lethal means of predator control, available statistics on the types of wildlife taken, responsibility of ranchers in protecting their investment, support for protecting wildlife. A representative of In Defense of Animals presented a petition expressing opposition to County funding to support the activities of the USDA Wildlife Services. Several of the speakers also expressed appreciation for the efforts of Mr. Carlsen, commented on the difficulty of the predator control policy issue and expressed support for the direction of the plan in moving away from funding a lethal predator program.

In response to a question from Supervisor Brown, representatives of the Marin Coalition for California Wildlife stated that their organization supports the Plan with modifications, noting that the Coalition is not opposed to the time period set out in the Plan for the phase out of the lethal program.

Coalition representatives also stated that the Coalition would convey their support for the Plan, with recommended modifications, to its membership, provided that the Plan includes a clear 18 month phase-out of County funding for lethal methods.

Mr. Carlsen clarified the phase-out period for continued funding of a lethal predator program noting that June 30, 2002, would be the end of the County's contract with the USDA Wildlife Services program.

Three ranchers, the Executive Director of the Marin Agricultural Land Trust ("MALT") and the State Director of the USDA Wildlife Services addressed the Board and commented generally on the efforts of ranchers in implementing non-lethal methods for predator control, outlined various services provided by the USDA Wildlife Services, commented on misconceptions of ranchers and their efforts on non-lethal methods for predator control, encouraged the application of science to guide wildlife management issues, described benefits of the services provided by the USDA Wildlife Services, emphasized the importance of preserving agricultural viability in the county, outlined problems related to the termination of the Wildlife Services Program last year and detailed losses on ranches due to predation.

The public hearing was closed.

Mr. Carlsen responded to questions from the Board and clarified some comments made during the public hearing regarding oversight and administrative controls of the proposed contract with the Woolgrowers Association and County contracts in general, the period by which the agreement with the USDA would "sunset", and the availability of other programs and industry groups, beyond the Northbay Woolgrowers Association, for wildlife and livestock protection.

Thereafter Supervisors individually expressed appreciation to Mr. Carlsen for his work, expressed interest in ensuring representation by other industry groups in implementing non-lethal predator control activities, commented on the progress made on this policy issue, stressed the importance of preserving viable agriculture, expressed appreciation to the USDA and for the appearance of the USDA State Director of Wildlife Services at today's hearing, acknowledged the investment of the USDA in researching non-lethal methods and encouraged continued research in this area, stressed the importance of maintaining food security, emphasized the importance of accountability of the program, and expressed appreciation to the representatives of the Little Blue Society for their presentation.

In response to questions from the Board, Mr. Carlsen stated that he felt that the Northbay Woolgrowers Association was the best vehicle to administer the non-lethal program because that organization represents the majority of the sheep producers in the county, and traditionally the losses and damages have been focused on the sheep industry. Mr. Carlsen also briefly commented on the relationships that will continue to be maintained among all county ranchers, the County, the USDA and the University of California Cooperative Extension/Farm Advisor's Office. Mr. Carlsen also noted that the Northbay Woolgrowers Association has agreed, in concept, to the proposed agreement to implement a non-lethal program.

Thereafter, M/s Kress-Rose, to:

a. Approve five-year action plan to develop, implement, monitor, and evaluate a sustainable livestock/wildlife protection program;

- b. Approve Marin County Strategic Plan for Wildlife Control Techniques on Livestock Operations;
- c. Authorize the President to execute cooperative agreement (No. 00-73-06-0259-RA) in the amount of \$15,000 with the United States Department of Agriculture ("USDA") to provide for animal damage management within Marin County;
- d. Approve inclusion of \$37,500 in 361-2267 to fund Northbay Woolgrowers Association to implement non-lethal predator control activities.

Supervisor Brown stated that he would vote against the motion for several reasons, and stated that the County should take a significant interest in the livestock losses, suggesting that the County subsidize agricultural losses due to predation, and emphasized the importance of the preservation of viable agriculture in the county.

Thereafter, the vote on the pending motion was

The Board recessed at 3:02 p.m. and reconvened at 3:10 p.m., at which time Supervisor Kinsey was absent.

22. HEARING: RICHARDSON BAY DOCK AND BOAT STUDY [Richardson Bay]

Community Development Agency Director Alex Hinds briefly summarized the history of the Richardson Bay Dock and Boat Study ("Study"), noting that the Study is the result of the Board's direction to staff to undertake a cumulative impact study of boat docks in the vicinity of the Audubon Society's Richardson Bay Wildlife Sanctuary. Mr. Hinds introduced consultant and Study author Greg Zitney of Zitney & Associates and noted that the Study was unanimously recommended for approval by the Planning Commission in October.

Principal Planner Thomas Lai stated that correspondence regarding the Study from residents of Harbor Cove Way and Greenwood Beach Road was received and distributed to Board members. Thereafter, Mr. Lai discussed the information contained in his staff report dated October 31, 2000.

Mr. Lai briefly outlined the background of the study, identified the study area and reviewed the environmental setting of the study area. Mr. Lai summarized the Study findings including the potential impacts of docks on wildlife and habitats; the impact of boat traffic, including personal watercraft, in the study area; and the potential for the creation of private docks and a commercial marina. Mr. Lai also summarized the results of a survey conducted to identify existing and potential dock sites in the study area and emphasized that the recommendations in the draft Study are advisory only to the Town of Tiburon and City of Belvedere.

Mr. Lai highlighted the recommendations of the Study including designating Aramburu Island as an official wildlife preserve; increasing public awareness of the preserve and restrictions in the adjoining sanctuary; strengthening enforcement and penalties for violations of the restrictions in the sanctuary; prohibiting boat traffic, including canoes, kayaks and rowboats, from traveling up the eastern side of Aramburu Island; establishing specific guidelines for dock construction within the unincorporated portions of the study area,

including limiting size of docks, and using construction methods and materials that minimize shoreline and aquatic impacts. Mr. Lai recommended that, after review of the administrative record and conduct of a public hearing, the Board adopt a resolution approving the Richardson Bay Dock and Boat Study. Mr. Lai stated that, upon adoption of the Study, staff intends to use the Study as an informational tool in the processing of development applications for new boat docks within the study area, including the preparation of environmental review.

Mr. Zitney responded to questions from the Board regarding the definition of "personal watercraft" as used in the study, noting that, personal watercraft, as defined for the purposes of the study, is generally a one-person craft that is portable.

Community Development Agency staff responded to a question from the Board regarding the impact of the Study on docking facilities stating that the intent of the Study was to review the cumulative effects of additional docks and to evaluate the potential for additional docks in the study area.

The hearing was declared open to receive public testimony.

Residents of Greenwood Beach Road, Egret Way, Harbor Cove Way and Century Drive expressed their individual concerns related to the history of dock use in the affected study area, the economic impact on homeowners in the study area, perceived deficiencies of the Study, expectations of homeowners in the study area to construct docks, the possibility of legal action related to enforcement of the Study, a request to adopt the Study as advisory only, the lack of differentiation between small watercraft and motor-powered boats, recognition of navigational easement rights, and potential dock sites identified in the Study. A resident of Harbor Cove Way commented on Appendix B of the Study regarding the Strawberry Recreation Dock, potential dock development east of the Strawberry Public Dock, and recent dredging assessments and read a portion of the Appendix ("Response to Letter C").

There being no further comment, the hearing was closed.

Mr. Lai responded to comments from Board members related to questions raised by residents in and near the study area who spoke at today's hearing stating that the Study does not change any regulations used by the Town of Tiburon to review boat docks within its jurisdiction. Mr. Lai stated that a copy of the Study has been distributed to the Town and noted that the Town Planning Director's reply is included in the Appendix of the Study.

Mr. Hinds emphasized that the purpose of the Study was to address the cumulative impact of additional docks and stated that the Study is not intended to prohibit personal watercraft or to limit people's current property rights or enjoyment of the area. Mr. Lai added that the Study is not intended to create a new set of regulations binding on the properties in the jurisdictions of Tiburon and Belvedere.

Mr. Lai responded to questions raised at today's hearing by a resident of Egret Way regarding the methodology used in the Study for determining whether or not a lot has potential for dock development. Mr. Lai identified methodology considerations including access to the waterfront, zoning restrictions that would prohibit dock or other similar recreational developments on the lot and existing development conditions tied to land use entitlements that would prevent the ability of the property owner to apply for boat docks in the future. Mr. Lai further responded to concerns raised by a resident of Harbor Cove Way,

briefly commenting on conditions of approval for the Harbor Cove Way land division, and staff's interpretation of the land division condition pertaining to development of additional boat docks.

Discussion continued with regard to the 1978 conditions of the Harbor Cove Way land division approval and future dock development.

Supervisor Murray requested that approval of the Study include a statement that the document is advisory only and requested that the use of the term "personal watercraft" be clarified in the Study.

Thereafter, M/s Rose-Kress, to adopt Resolution No. 2000-136 approving the Richardson Bay Dock and Boat Study, to be modified to clarify the definition of "personal water craft", to clarify the intended use of the Study, and to clarify concerns raised at today's hearing.
